AND

M/S PATRICIAN COLLEGE OF ARTS AND SCIENCE, (PAN: AAATT5684M), incorporated under the provisions of Companies Act 2013, represented by its Director and Secretary **Bro.Dr.A.Stanislaus**, having its registered office at, Canal Bank Road, Gandhi Nagar, Adyar, Chennai - 600020 – hereinafter referred as **Second Part** (which expression shall unless excluded by or repugnant to the subject or context be deemed to include its successors-in-interest and permitted assigns)

Whereas the PARTY OF THE FIRST PART initiate the project as "GREEN CAMPUS INITIATIVE" to place a Solar Street Light in the name of "SMART POLES" in the College. The said SMART POLES, each worth a sum of Rs.40,000/- plus applicable taxes and approximately with Weight of 40 kg, Height of 16 feet which contains Solar Panel at the top on each Smart Pole integrated with Li-ion 1 battery (power saver) on each smart pole, LED Lights, First Aid Kit ;it has 2 sides of advertisement space on each smart pole covered by Acrylic sheets and Translit Print on 2 sides; Advertisement / Branding Size: 3 feet (Height)X 2 feet (Width) of the Smart pole.
